## Introduction

Guy Proulx welcomed the directors to the meeting.
Minutes of the meeting of June 12, 2019

## Update of Past Events

Wine Tasting - June 13, 2019

Hosted by Jean-François and Joanne again at the Perreault Winery in Navan. We had a total of 45 reservations. One person had to cancel and was reimbursed, two people did not show up and one person joined us without having registered, therefore, we had 43 attendees. The Winery provided us with two bottles of wine and the committee purchased three additional bottles which were given as prizes in addition to the 50/50 draw. The $50 / 50$ netted $\$ 170$. Once all bills were paid, the committee netted a profit of $\$ 78.66$

The evening was a bit different from last year. The participants had the opportunity to sample five wines. Contrary to last year, the host did not explain the wines that we were sampling except when ask at the individual tables. Although it was raining, the activity was a success. Only positive feedback was received. Everyone seemed to have enjoyed their evening and we highly recommend a repeat.

The committee purchased cold cuts and cheese trays, salads, shrimp trays, crackers, chips, veggies, fruits and desserts which were appreciated from the participants. If we repeat this activity, recommendations are that the QCC supplies the food and we purchase the same tasting package.

## Boat Cruise - August 14, 2019

The annual Casino du Lac Lemay Fireworks cruise was held August 14th. Although we had a number of 200 paid registrants, we had nine no shows without notification.

The 50/50 netted $\$ 475$ - three people each won $\$ 135$ and $\$ 70$ to the QCC. We also gave away $25-\$ 20$ LCBO gift cards.

It was a beautiful evening featuring Italy. We had a few new participants and a good mix of QCC and YPN. Many mentioned that they enjoyed their evening. There was no smoking on the boat and doesn't seem like anyone minded. The ship was able to stay pretty well stable with the nose pointing towards the fireworks. That was an improvement over some previous years.

We had enough snacks and very little leftovers. We have a few supplies on hand for next event such as paper plates and serviettes.

Again, this year, we had to track down some people that had registered and were not paying. We collected some $\$ 4,700$ of our $\$ 6,000$ by way of interac payments; definitely the way to go. Guy was able to set up direct interac deposit by creating a specific internet address for that purpose and worked well after a bit of a learning curve. If this approach is used in future, the event organiser will need to note the transaction number for each payment as once amounts are deposited in QCC account we lose track of the name of the payer.

This year we chose to draw the names of the prize winners prior to the boarding of the ship, names were taped on our large poster and folks were asked to bring their name to
the organisers to claim their prize. This minimized disruptions and gave more time to participants to dance and enjoy themselves.

Once all bills were paid, the committee netted a profit of $\$ 1,565.93$.
Gastronomic Dinner with Wine Pairing -September 10, 2019
Hosted by Jack, Joanne and Luisa. The Dinner and Wine Pairing was held at Divino Wine Bar on September 10th.

Although the number of participants went up to 53 , there was a few cancellations during the two weeks prior to the event and the final registrations was 41.

It was a great evening, featuring an excellent selection of wine and Italian food. Participants had to choose between Insalata or Zuppa as their antipasto, the choice for the secondo was Gnocchi, Pesce or Melanzane and then Torta Caprese or Gioccolato for dessert. Each service was paired with a 3 oz glass of wine. Martin, the owner commented on the wines as he was serving.

Everyone who attended seemed pleased with the evening and we received a lot of positive feedback. The service and the food were excellent.

We did not sell 50/50 tickets but we gave everyone a ticket for door prizes. The prizes were $\$ 20$ and $\$ 15$ LCBO cards that we had from previous activities.

This activity did not raise any money.
